Raja Vijayaraghavan V., J.

This SSCR has been placed before us to ensure, review and affirm the adequacy of the special bandobust arrangements at Sannidhanam, which are invariably undertaken in the first week of December every year, having regard to the historical background of certain grave incidents associated with this period and the heightened sensitivity that the anniversary of such events continues to attract.

- 2. We have carefully examined the detailed report submitted by the Additional Director General of Police and Chief Co-ordinator, Sabarimala. The report details the proposed deployment of security personnel, access-control measures, surveillance protocols, intelligence coordination, and crowd-management strategies intended to ensure an atmosphere of calm and safety and to prevent any untoward event.
- 3. Having considered the materials on record, we find the report to be satisfactory, comprehensive, and well thought out. The Chief Co-ordinator shall, however, remain alert and shall ensure that all precautionary measures are implemented without exception. It shall be his responsibility to see that no stone is left unturned in strengthening the security architecture, maintaining seamless

inter-agency coordination, and preserving a smooth, secure, and safe environment at Sannidhanam throughout the critical period.
